### IMPORTANT INFORMATION

**DOGS ELIGIBLE TO ENTER:** Dogs of any breed who are at least 12 months of age that are registered with the AKC, recorded in the FSS program, dogs with PAL numbers or dogs enrolled in the Canine Partners program. Bitches in season may enter but must wear pants. Bitches in Season may be tested as the last dog(s) at the end of the day. Dogs with disabilities may participate in the ATT test. However, if a dog has multiple disabilities (e.g., blind and deaf), such that it is unable to perform whole categories of the test (such as hearing auditory stimuli and seeing visual stimuli), the dog would not earn the ATT title.

**TEST ENTRY FEES:** Each pre-entry \$30. Day-of entries \$40, and are accepted starting at 11am March 26, 2023, provided entry limits have not been met. Please check Sportsmen's Facebook page at **sportsmensdtc** for updates.

Entries will be accepted via mail only. Express mail entries must include the signature waiver allowing them to be left at the secretary's address. Direct inquiries to Mildred Krnacik at mkrnacik@hotmail.com. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$35.

Test 1 and test 2 will run concurrently. Dogs will be run through test 1 in ring 1, then exit the building and wait a minimum of one hour before running test 2 in ring 2. Running order will be kept via white board at the entrance to the building.

Day-of entries will be run at the end of morning and afternoon sessions, after all pre-entries have been run. A dog may enter only once per test, and one test is defined as one event number.

**Safety of the dog** is our primary concern. By entering this test, exhibitors acknowledge that they are familiar with the rules and regulations of this test. Exhibitors should review all testing information found at [www.akc.org/akctempest/](http://www.akc.org/akctempest/)

**Collars, Leashes and Harnesses.** Slip collars that are on the dead ring, buckle collars, Martingales and body harnesses may be used in the ATT. They may not wear prong collars, e-collars, head collars, or harnesses that restrict the movement of the dog. Leashes should be 4 ft. to 6 ft. long and should be made of fabric or leather. Dogs must be on leash at all times. No retractable leashes on the grounds.

**REFUNDS** There will be no refunds unless approved by the event committee. Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

#### ADDITIONAL SITE INFORMATION

**Crating space will not be available indoors.** Dogs must be crated in cars so as not to become desensitized to the audible portions of the test. Handlers may wait inside. Please ensure your dog is comfortable and has water available. We are scheduling each team to take both tests in either morning or afternoon slots to minimize waiting time.

**Handlers are responsible** for cleaning up after their dog(s). Cleaning supplies and disposal sites will be available.

#### RIBBONS AND AWARDS

White ribbon awarded to each dog that passes the test. Medals for dogs that title.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog.
